1. Cut -off Date:

The voting rights were reckoned as on 21.02.2025 being the cut-off date for the purpose of deciding the entitlements of members for E-voting during the course of Postal ballot.

2. E-Voting

Company had appointed KFin Technologies Private Limited ("KFintech") as the agency for providing e-voting platform.

The evoting platform was open on Thursday, 27th day of February,2025 from 9.00A.M (IST) till 5.00 P.M (IST) on Friday the 28th day of March,2025. Members were required to cast their votes electronically conveying their assent or dissent in respect of resolutions stated in the notice of Postal ballot dated 04.02.2025 of the company.

3. Voting facility

Company had made arrangements for voting electronically for the resolutions stated in the postal ballot notice for a period of 30 days i.e., from 27.02.2025 to 28.03.2025.

In Compliance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations,2015 as amended (the "SEBI Regulations") and pursuant to the provisions of section 108 and 110 of the Act read with rules framed thereunder and the MCA circulars, the manner of voting on the proposed resolution is restricted only to e-voting i.e., by casting votes electronically instead of submitting postal ballot forms.

4. Counting Process

On completion of e-voting, I unblocked the results of the e-voting, on the Kfintech e-voting platform and downloaded the results.
