

The E-voting platform was open from 10.00A.M (IST) on Thursday the 16<sup>th</sup> day of February.2023 till 5.00 P.M (IST) on Friday the 17<sup>th</sup> March.2023. Members were required to cast their votes electronically conveying their assent or dissent in respect of resolutions stated in the notice of Postal dated 03.02.2023 of the Company.

### 3. Voting facility

Company had made arrangements for voting electronically for the resolutions stated in postal ballot notice for a period of 30 days i.e., from 16.02.2023 to 17.03.2023.

On completion of e-voting, 1 unblocked the results of the e-voting, on the K fintech - evoting platform and downloaded the results.


5. Results:


